- (ii) The subject of Pakistan Studies (Compulsory) shall be taught in Grade-10 (Part-II) carrying 100 marks with effect from the Academic Session 2025-26 onwards and the teaching of Islamiyat (Compulsory) in Grade-10 (Part-II) shall be discontinued with effect from the Academic Session 2025-26 onwards.
